

**Official Reminder**

With respect to the above subject and reference, as the government sanctioned 8.00 acres of feedlot land in survey no 36 and allowed to start Morarji Desai Residential School in Masthenahalli Village, Kaiwara Hobli, Chintamani Taluk. The above said land is situated 1.5 kms distance from the village. The sanctioned land is a part of 330.12 acres of feedlot and it is classified as 'Government Feedlot' for the cattle's of the villagers. So, Assistant Commissioner of Chikkaballapura are recommend to Transfer the said land as there is no any further objections from the villagers, to transferred to the Department of Minorities Welfare for construction of School building.

After verifying the facts in the report of Assistant Commissioner of Chikkaballapura the above said land is transferred to the department of Backward Classes and Minorities Welfare on condition by reducing 8 acres in survey no 36 which is under government title as Government Feedlot' through Under section 71 of Karnataka Revenue Act-1964, and G.O no: R.D.11 .LGW.71, Bagnalore Dt.20.05.1971, and as per the directions in government circular R.D.70.LPG.2008 Dt.08.08.2008.

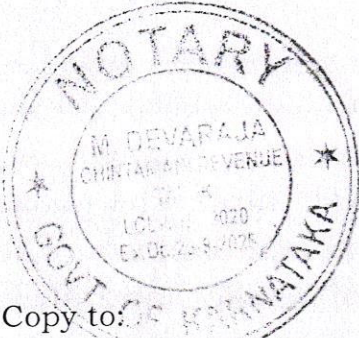

- 4) The granted land should be utilized only for the purpose mentioned and there will be no rights to have on land without prior permission of Revenue Department.


