Subject: Regarding to provide land in Sy. No. 108-8 admeasuring 6-16 acre situated at Konaje Village Mangaluru Taluk for Morarji Desai Residential School for Minority Girls as per Order of Karnataka Land Reforms Act, under Section 71.

The property situated in Sy. No. 108-8 admeasuring 6-16 acre land situated at Konaje Village of Mangalore Taluk is a government-owned land and as per Reference (1) Order, the land has been dismissed from Kumki right and there is no illegality. The said land is 2 KM distance far from the National Highway and as per Reference (2), Mangalore Taluk Tahsildar have submitted a proposal to keep said land for the purpose of Morarji Desai Residential School for minority girls.

The public Opinion has been asked to reserve the land and there are no objections and as requested by the Requesting department, there is no objection for reservation of said land for the proposed purpose.

In view of all these reasons, the property situated at Konaje Village of Mangalore Taluk in Sy. No. 108-8 admeasuring 6-16 acre land is allotted for the public purpose i.e for the purpose of Morarji Desai Residential School for Minority Girls and the Minorities Department on the basis of the below mentioned conditions as per Karnataka Land Revenue Act, under section 71.

1. The said land should be used only for above said purpose and shall not be used for any other purposes.
2. Shall not make any transaction regarding the above said land
3. Do not make any irregularities in the said land. The Revenue Department is not responsible for any irregularities.
4. If there are trees grown on the reserved land, they shall be disposed by the Forest Department.
5. The above said work shall be started within two years after sanction of this order.

In case of violation of above said conditions, the said Grant Order shall be cancelled and the developments made in the said land shall be taken into possession by the Government without paying any compensation. The Tahsildar of Mangaluru Taluk shall transfer, the said land to the related person and receive the receipt and Order Indexed RTC copy should be sent immediately to this office.

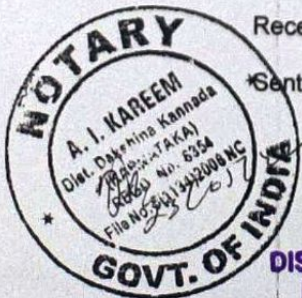
